#### Communication

La Nouvelle Port control and La Nouvelle Pilot are working on VHF 12. Vessels must keep watch on VHF 12 two hours before arrival. In the fairway and waiting anchorage, vessels must also keep watch on VHF 12 and 16 with Leucate signal station.

#### Pre-arrival information required for the port

Inward declaration 24h prior Dangerous goods declaration Ship Security Pre-arrival information Waste and residue notification Maritime declaration of Health Ship sanitation certificates Certificate of insurance Crew and passengers list These information must be transmitted by the agent via CAPSUD software.

#### Fairway, anchorage

In accordance with French Maritime Authority regulation:

A fairway of 6 nautical miles long is compulsory for ships carrying MARPOL dangerous goods. Inbound vessels use north way and outbound vessels south way.

There are two anchorage areas on roads, the northern anchorage is compulsory for vessels carrying dangerous goods. Access is subject to authorization of the French Maritime Authority (contact through Leucate signal station on VHF 12/16).

Transit time from anchorage to quay: 30 to

Due to an underwater pipeline in the port, anchors cannot be used without pilot's advice and any case must be reported to Harbour Master's Office.

#### Pilotage

Pilot is compulsory for :

1/ All vessels with LOA above 45m. 2/ All vessels carrying dangerous goods.

Pilot boarding position depends of vessel type and weather conditions, usually 1 nautical mile distance from breakwaters.

1 tug x 20 tons and 1 tug x 12 tons

1 pushing boat

Tug is compulsory for some ships detailed in the port's rules. Any tug requirement may be requested by Harbour Master for safety reason.

#### Mooring generalities

The mooring remain under the responsibility of the ship's masters. The number of mooring lines must be increased if necessary. During the call, there is an effective watch on board in order to check and adjust the mooring and the gangway.

#### Ballast procedures

Vessels must be in full ballast condition before entering the port.

Ships with abnormal trim or list must warn the harbour master's office

It is strictly forbidden to pump out dirty water

#### Repairs alongside

Any repair will not be carried out without the permission of harbour master's office. Fire fighting and mooring equipment must be in good working condition.

# and fresh water

Ship's stores and bunkering available by lorry, it must be done out of loading and ballasting operations.


Fresh water available on berth, on demand to the harbour operator.

Harbour master's office must be informed before any operation.

# Port and terminal pollution prevention regulations

MARPOL convention must be observed. Any pollution of port waters must be immediately reported to harbour master's office. Anti pollution equipment are described on plan.

# Generalities on Weather conditions. density of water, tide and current (for more information see Sailing Directions)



The main wind comes from the NW, with this weather condition the sea state keeps calm. SE wind causes some waves inbound, the mooring arrangements must be checked. Density of water is 1.025 but subject to change.

Current is about 1 to 2 knots but can be stronger during flood.

Range of tide is almost 0.3m but the sea level can reached 1 m above mean water level during periods of flood.

Steps to be taken on board

- Give a sound signal of 7 short blasts and 1 prolonged blast
- Take initial safety and fire fighting measures on board
- Stop commercial operations
- Disconnect hoses or loading arms
- Make the ship ready to get underway
- Ship's crew must be able to guide emergency service on board
- Plans of the ship, type and quantity of any hazardous materials must be given to the emergency team
